

## Services

A six-bed secure Evaluation and Stabilization Unit (ESU) provides a safe transition for girls who initially may need more intense supervision. The open unit has the capacity to serve 24 girls who can benefit from a more open environment.

In addition to the clinical services, each girl benefits from expressive therapies, vocational and recreational opportunities, and healthy outdoor experiences including a full equestrian program—all of which encourage responsible and accountable behavior in a safe and supportive environment.

Girls who are pregnant are not excluded from admission to the program. The clinical and medical staff work closely with the family and referring agencies to provide appropriate care for the expectant mother, for placement of the baby following birth, and for ultimate reconciliation of mother and child following discharge from the program.



# Eastway Behavorial Healthcare The Ranch of Opportunity Residential Treatment Services

Our 22-acre tranquil ranch, located in Washington Court House in Fayette County, is unlike any residential treatment facility in the country. Set in a spacious, secluded, rural setting, our mission is to provide chances, choices and hope for young women in need of a fresh start.

Our experienced and compassionate staff work with the girls and in many cases their families, to break the vicious cycle of child abuse and address the self-destructive behaviors brought on by experiencing severe trauma in childhood.

The Ranch of Opportunity facilities include a 30-bed residence, a visitor center and equestrian facility filled with horses and barn animals that the girls use in therapy and lovingly look after.


The Ranch serves girls from 13-17 years of age. During a six month stay, girls have the freedom to live, learn and grow—all in a peaceful, safe environment far away from the abuse and neglect they've experienced. Many of these young women present with co-occurring mental health, behavioral, and substance abuse disorders that cannot be isolated and treated separately. For this reason, the program takes a holistic approach to treatment and wraps a continuum of specialized services around each girl.
